In this role, she provides leadership for the university's strategic research agenda into the security, politics, economies and development of the Asia-Pacific; promotes high level dialogue and informed community debate on issues of significance for Australia's engagement in the region; and facilitates Griffith Business School's global internship program.

Caitlin brings a unique mix of academic expertise International Relations and Diplomacy Studies with hand-on experience in international policy and diplomacy gained in Australia and abroad. Her research into public diplomacy and soft power in the Asia-Pacific, is recognised internationally, and published in journals including Australian Journal of International Affairs, Hague Journal of Diplomacy and Politics & Policy. Her skills in strategic policy and strategy design, stakeholder engagement and curriculum development reflect more than 20 years' experience working across government, academic, corporate and community sectors.

# Journalist and Industry Fellow, Griffith Asia Institute

Rowan Callick grew up in England, graduating with a BA Honours from Exeter University.

He worked for a daily newspaper in the north east before moving in 1976 to Papua New Guinea, where he became general manager of a locally owned publishing, printing and retail group.

In 1987 Rowan moved to Australia, working for almost 20 years for The Australian Financial Review as Asia-Pacific Editor. He was China Correspondent based in Hong Kong, from 1996 to 2000.

From 1990 to 1992 he was a senior writer with Time magazine.

Rowan joined The Australian at the start of 2006, as China Correspondent. After three years in Beijing, he became The Australian's Asia-Pacific Editor at the start of 2009. He returned to Beijing as The Australian's China Correspondent from January 2016 to April 2018.

His work has also been published widely elsewhere, including The Wall Street Journal, Foreign Policy magazine and The Times

He has spoken on Asian and Pacific topics, especially on China, at many university campuses in Australia; New Zealand; China; in June 2018 at the School of Oriental and African Studies at London University; and at international conferences in Asia including the 25th Asia-Pacific Roundtable of the Institute of Strategic and International Studies Malaysia.


